Ocean Freight Forwarders and NVOCCs Missing information?

- The License Update System pulls information from multiple FMC databases
 - Registered Persons Index (RPI) manually updated by the FMC staff
 - FMC1 (Tariff) as <u>electronically</u> submitted by OTI
 - FMC18 (License application) as <u>electronically</u> submitted by OTI
- Some OTIs have never submitted electronic application(s) with the FMC
- The License Update System may not prepopulate the following:
 - Branch Offices
 - Officers
 - Ownership
